BACKGROUND

TechShare.Defense is a web-based case management software solution for defense attorneys. The initial project to build the application began in late 2012 with four Texas counties that had a need for a prosecutor case management system. The scope of the project also included building a law enforcement agency portal and a defense attorney portal. The portals enable efficient transfer of information between stakeholders in the criminal justice system. Together, these applications improve visibility and efficiencies throughout the life cycle of a case.

In addition, TechShare also offers a web-based case management systems for counties to more effectively monitor and manage indigent defense requirements in compliance with the Fair Defense Act. This system manages the determination, appointment, and reporting required for defendants qualified to receive court appointed counsel.
